# **2025 Holiday Tree Guidelines**

The Appleton Museum of Art, College of Central Florida, invites you to decorate a tree for display at the museum from November 1, 2025—January 11, 2026, alongside The Urban Family's beloved annual holiday exhibition. ### TREE GUIDELINES

#### **TREES**

- All trees must be artificial pines provided by you, the participant.
- Trees must be at least 5 feet tall, and with decorations, may not exceed 10 feet in height or 5 feet in width.

#### **DECORATIONS**

- Participants must provide all decorations for their tree or display. A tree skirt or tablecloth is required.
- Decorating with live plants, food or flammable materials is prohibited. This includes, but is not limited to: berries, popcorn, dried fruit, candles, aerosol snow or tinsel.
- All decorations must be securely fastened to the tree using floral wire, pipe cleaners, or similar materials.
- Need inspiration? Scan the QR code below to see some trees from previous years.

#### **LIGHTS**

- All trees must be lit; flood lights are not permitted.
- Lights must be continuous burning no blinking or chase lights on the tree or toppers.
- Test all lights before installation to ensure they work. If any lights burn out, you will be notified and asked to replace them.
- To avoid early burnouts, we recommend using only newly purchased lights.
- All lights and decorations must comply with current fire codes; look for the UL Approval Code on packaging.

#### **MISCELLANEOUS**

- The museum is not responsible for lost or stolen decorations or display pieces.
- Participants are encouraged to express creativity and originality; however, trees should reflect the identity of your business, organization or family.
- The museum reserves the right to remove any ornament or tree deemed offensive or inappropriate for visitors. This is a family-friendly event attended by guests of all ages and should embody the spirit of the holiday season.

### THE APPLETON WILL PROVIDE:

- Electrical hookups.
- Foot switch for turning tree or display lights on and off.
- Signage for your display.
- Social media posts highlighting your organization or business.

#### PARTICIPANTS ARE RESPONSIBLE FOR:

- The delivery and set up of tree and all decor on Monday, October 27, 2025.
- Step stool or ladder to use while decorating and any tools required to securely fasten all decorations to the tree.
- Removal of the tree and all decorations on Monday, January 12, 2026.
